Other indirect GHG Emissions (Scope 3) from well to tank emissions related to scope 1 fuel use, travel related to third provider associates, business travel, and office activities (material use, water, electrical transmission and distribution)

**Exclusions from Reporting Boundary:**

Indirect emissions that have been determined not to be significant by the organization on the basis that they are either <1% of the total GHG emissions, or there is insufficient information to make an accurate assessment of their contribution to the total GHG emissions have been excluded. This includes the following: -

- Employee commuting
- Rail Travel
- Waste
- Material use (other than paper/electrical items)
- Water use at the Bromley office

### **Verification Opinion: Verified with Comments**

- 1) For calculation of scope 1 natural gas and scope 2 electricity, where there has been occasional missing monthly data, the organisation has used a conservative estimate based on known data.
- 2) The calculation of scope 3 emissions relating to fuel use in transport by associates has been estimated based on available information provided by 32 associates (out of a total of 56 associates)

The following improvements were raised in relation to future reporting:

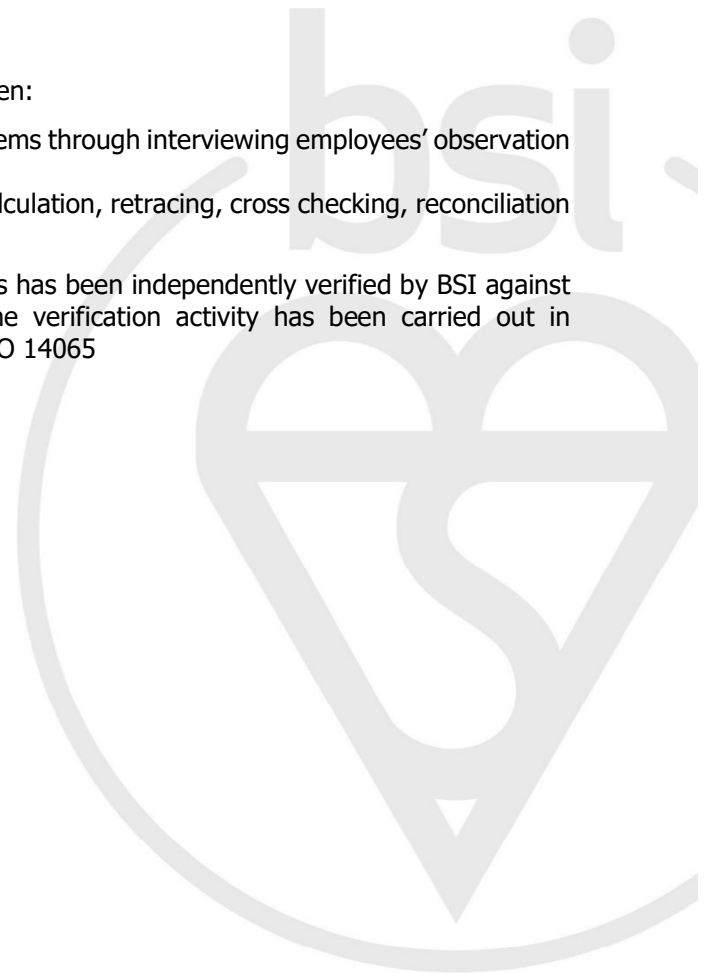
- 1) GHG inventory quality management procedures should be reviewed to ensure appropriate routine and consistent checks are effectively in place to ensure accuracy and completeness of the GHG inventory.

### **Verification Activities:**

The following were the verification activities undertaken:

- Evaluation of the monitoring and controls systems through interviewing employees' observation & inquiry
- Verification of the data through sampling recalculation, retracing, cross checking, reconciliation

The quantification and reporting of the GHG emissions has been independently verified by BSI against the specifications defined in ISO 14064-1:2018. The verification activity has been carried out in accordance with ISO 14064-3 and the principles of ISO 14065
